Capital Facilities Committee reviews all staff		
proposals for major equipment purchases, capital		
improvements, and major maintenance and repair		
expenses and, as needed, makes recommendations		
to the full Board for approval.		
Finance Committee reviews the overall budget,		
recommends adjustments to the budget during a		
fiscal year, recommends policy changes and makes		
its proposals to the full Board for approval.		
Programs & Outreach Committee reviews		
budget projections and recommends policies		
associated with MCC's programs; advises on		
matters pertaining to communications and		
marketing, and as needed, makes recommendations		
to the full Board for approval.		
Elections & Nominations Committee oversees		
procedures for the annual election of new board		
members and the nomination of officers for the		
coming year. Members with expiring terms who		
intend to run again for a board seat may not serve		
on this committee.		
50th Anniversary Committee – envisioning a		
year-long celebration of MCC's 50 th anniversary in		
2025. Committee provides guidance to the Board		
and feedback to the MCC staff on the strategic		
direction of the anniversary plans including		
themes, outreach, marketing, fundraising,		
sponsorships and events.

Additional information:

- The Executive Committee is composed of the board officers: Chair, Vice-Chair, Secretary, Treasurer.
- Adult board members serve on two, or up to three committees.
- Youth board members serve on two committees.
- Traditionally, the board Vice-Chair chairs the Capital Facilities Committee.
- Traditionally, the board Treasurer chairs the Finance Committee.
- Most of Finance Committee's work begins in July, continuing through the board's approval of the annual MCC budget in October. There may be more than one meeting in some months. Finance Committee meets approximately quarterly. It is helpful if Finance Committee meetings can be later in the week (not Monday or Tuesday) because there is often incoming financial information from the county on Mondays/Tuesdays that must settle and be prepared as charts/tables for the Finance Committee.
- The term of service for *Ad hoc* 50th Anniversary committee members has different parameters: originally convened in September 2022; ongoing through December 2025 (50th anniversary year). Board members rotating off during this time frame are welcome to continue serving on the committee as community representatives.
- Chairing committees: because of your experience and expertise, you may be asked to consider chairing a committee.
